- Prior to Our Kids, Miami made national headlines for the disappearance of a child named Rilya Wilson
- Rilya Wilson is still missing today
- Her case worker, who falsified her home visits, was prosecuted
- Our Kids, a non-profit 501 (c) (3) agency, was created specifically to respond to the State of Florida's request to privatize Miami-Dade and Monroe's counties foster care system





- Train, train and re-train
- Strict scope control
- Vendor partnership
- First the carrot, then the stick

Cost model



- One-time cost of \$587K for computers, phones, software and launch expense
- Recurring cost per child per year is \$6 per month per child
- Statewide implementation
