Video project features interviews from Afghan cultural leaders to inform and guide the practice of child welfare professionals working with Afghan families.



Jessica Toft (Elin Amundson, Channel Lowery) Podcasts

Two podcasts, Social Worker Professional Discretion: New Ideas and Stories from the Field and Social Worker Resistance to Managerialism: New Ideas and Stories from the Field, discuss the concepts of professional discretion and resistance and how these concepts play out in social work, particularly in child welfare.

A series of **infographics**, *Hmong Families in the U.S.: Adjusting to Western* culture, highlighting Asian American families experiencing acculturation stress surrounding parenting issues.

Saida Abdi (Johara Suleiman) **Experiential Learning Day**

Planned and hosted experiential learning day in the Somali community for Title IV-E fellows. Somali experiential learning is a new one-day learning event in which students learn about the Somali American community, specifically in the Twin Cities, and and reflect on child welfare practice working with this population.

Planned and hosted experiential learning days in the African American Community (ELAA) for Title IV-E fellows. ELAA is a two-day learning event with activities providing opportunities to focus on significant historical and contemporary issues in the African American community and their relationships to current culturally relevant child welfare practice.

Katie Johnston-Goodstar **Experiential Learning Days**

Planned and hosted experiential learning days in the Native American Community for Title IV-E fellows. CELNA is a two-day learning event offering students an immersive experience to better reflect on child welfare practice working Indigenous families. Students explore significant and sacred sites learning about historical trauma, resilience, and racial disparity to better inform their child welfare work.

Center for Early Education and Development (CEED) Consultation Groups + <u>Website</u>

Host online consultation groups to train supervisors and front line workers in child welfare on reflective consultation supervision (RCS) and infant mental health. The online certificate builds foundational knowledge of child development for child welfare professionals.

Completed the development of a child development and child welfare **website** used to house and organize CEED and CASCW content so that related professionals can easily access this training information.



Center for Practice Transformation (CPT) Meeting Guides + Tools

The **meeting guides** support child welfare workers working with parents and caregivers. Guide topics include *Preparing for Stress, Refusing offers to drink or use drugs, Warning Signs for relapse, Pursuing my goals,* and *Stages of Support Resource Guide.* The meeting guides are designed to support CPS workers in 'meeting clients where they are' in their motivation to change and helping them make solid progress toward reducing their challenges related to co-occurring substance use and mental health disorders. Child welfare workers can download all the guides or individual ones.

Two **new tools** include an interactive *Weighing Pros and Cons* tool and a *Worker Wellness Guide* to benefit the worker themselves. The booklet guide includes tools for professionals to evaluate their own burnout, secondary traumatic stress and other related experiences as well as compassion satisfaction with validated tools and exercises.
